C. Motion to adopt Resolution 2014-14 Sustainable Economic Development Summary and Background

A resolution authorizing the city of Hapeville to become actively engaged with the Fulton County Economic Development Division in pursuit of innovative urbanregional economic growth strategies associated with the establishment of an **Innovation District** which focuses on a **CleanTech-GreenTech-LogisticsTech Eco-Industrial Development Corridor** in the vicinity of US-29 and the South Fulton Parkway in South Fulton County.

MOTION: Councilman Dimmick made a motion Councilman Powell seconded a motion to table Resolution 2014-14. Motion carried 3-0.

D. Consideration to adopt proposed Fire Department Fee Schedule. - Tom Morris Summary and Background

As requested, I have researched fee requirements from some of our neighboring departments. Hapeville uses Safe Built to perform our Building Plan Reviews and Inspections. The City does not have currently a Fire Alarm Plan and Sprinkler Plan Review fee. I recommend that the City implement a fee schedule comparable to neighboring jurisdictions to cover costs associated with Plan Reviews and Inspections.

MOTION: Councilman Dimmick made a motion Councilman Powell seconded s a motion to adopt the Fire Department Fee Schedule. Motion carried 3-0.

E. Consideration to approve the expenditure of \$11,508 to Cisco Smartnet. Summary and Background

Network availability is the most valuable resource to any business/organization. When network issues are not resolved in timely manner, it can bring a business or network to a standstill. The benefits of a Cisco SMARTnet are the following;

Quickly resolve issues = identify and resolve problems quickly before they significantly affect business continuity.

Empower IT Staff = Improve operation efficiency by keeping staff up to date on the latest technology advances and threats.

Mitigate Risk = Detect security issues that could negatively affect the availability, performance, & reliability of the network.

F. Consideration to enter into an Agreement with Fulton County for animal control services in the amount of \$9,454.34 from July 1, 2014 to June 30, 2015. Summary and Background Whereas The City of Hapeville has a need to provide animal control service to the residents of the city and provide housing for recovered animals. The city shall enter into an agreement with Fulton County for animal recovery and shelter services and agree to pay

the pre determined amount to Fulton County for these services.

MOTION: Councilman Powell made a motion Councilman Dimmick seconded a motion to enter into an Agreement with Fulton County for animal control services in the amount of \$9,454.34 from July 1, 2014 to June 30, 2015. Motion carried 3-0.

G. Consideration for City to enter into contracts with O'Brien Productions in an amount not to exceed \$6,800. to provide Event Services for the Happy Days Festival on Saturday, September 20, 2014 and for the Tree Lighting Event on Tuesday, November 25th, 2014. Summary and Background

Services will include equipment such as inflatable/generators, games and uniformed professional staff including DJ services and entertainers. Service provider carries general liability insurance. Council previously determined non-competitive negotiation for these contracts, staff solicited four quotes.

MOITON: Councilman Powell made a motion Councilman Dimmick seconded a motion to enter into contracts with O'Brien Productions in an amount not to exceed

\$6,800. to provide Event Services for the Happy Days Festival on Saturday, September 20, 2014 and for the Tree Lighting Event on Tuesday, November 25th, 2014. Motion carried 3-0.

H. Consideration for City to enter into contracts with Concert Audio in an amount not to exceed \$2,500. to provide sound and lighting services for the Happy Days Festival on Saturday, September 20, 2014 and for the Tree Lighting Event on Tuesday, November 25th, 2014.

Summary and Background

Services will include sound and lighting equipment and professional staff. Service provider carries general liability insurance. Council previously determined non-competitive negotiation for these contracts, staff solicited four quotes. The recommended service provider was the lowest quote received.

David Burt, Economic Development Consultant, stated that GMA was interested in using the City in a case study for the arts.

Tod Nichols, Recreation Manager, stated that VetFest, and the City yard sale was upcoming; that Fulton County had moved the fence on the bleachers on the King Arnold side of the football field.

Tom Morris, Fire Chief, ISO would be visiting on November 5th to re-evaluate the city's rating.

Rick Glavosek, Police Chief, stated that he had met with Sheriff Turner in relation to graffiti activity and creation of a database; and that the Department continued to work on code information issues.
