MINUTES

6:00 PM Work Session

Mayor Hallman called the meeting to order at 6:05p.m. at 700 Doug Davis Drive, Hapeville, Georgia 30354.

Councilman Richard Murray was absent.

Allie O'Brien, Main Street Manager, reported that Friday night would be Comedy Night and that the Main Street Board would be on hand to help with the event. Ms. O'Brien also stated that postcards had been mailed regarding fall/winter events.

Mike Clark, Finance Director, stated that he had spoke with the Fulton County Tax Assessor's Office and was informed that a 2009 digest had been delivered to the Tax Commissioner for approval. Mr. Clark stated that the City was still waiting on the 2008 digest to be certified. He further stated that the City was not anticipating a millage rollback. Also, the Finance Department prepared a Budget in Brief that was available on the website or at City Hall.

Rick Glavosek, Police Chief, reported that the suspect had been arrested in the Chapman Drug burglary case. Chief Glavosek stated that the Police Department was on track for certification by the end of the year and that a mock assessment would be held in November.

Tom Morris, Fire Chief, reported that he had attended an H1N1 workshop and that a vaccine would be available mid-October. He stated that it was the recommendation of the CDC for citizens to receive normal flu shots. Chief Morris further stated that he was currently working to have a re-evaluation for the ISO rating.

Ashley Smith, IT & Communications Manager, stated that he would be installing document imaging software. Mr. Smith statements that Wi-Fi network sign-ups would begin early October and that the login page would be much improved.

Paul Koster, City Attorney, stated that he would have proposed amendments to the Alcohol Beverage Ordinance at the mid-month joint meeting of Council and the Alcohol Review Board.

Mayor Hallman stated that he was waiting to hear from Congressman Lewis's Office regarding the Town Hall meeting. Mayor Hallman further stated that the TAD was on the mid-month agenda for Fulton County and would like to have representatives from the Council attend.
