X. Old Business

A) Consideration to approve or deny the conditional use permit for the operation of a grocery store at 3266 Dogwood Drive, applicant is Sandra Dempsey on behalf of BB&T. Public Hearing was held on December 2, 2008 by the Mayor and Council.

MOTION: Councilman Murray made a motion Councilman Valero seconded a motion to table application for conditional use permit for 3266 Dogwood Drive until February 3rd, 2009 at 7:00pm at 700 Doug Davis Drive. Motion carried 4-0.

- B) Consideration to appoint a facilitator for the annual Retreat.

 MOTION: Alderman Ray made a motion Councilman Valero seconded a motion to appoint Frank Foster, Facilitator for the annual Planning Retreat for \$1100.00. Motion carried 4-0.
- C) Motion to Adopt, Ordinance No. 2008- 20, Future land use map/COMPREHENSIVE PLAN amendment, 1st Reading 12-02-08 Summary and Background

Several amendments to the Future Land Use Map, part of the City's Comprehensive Plan, are necessary to reflect recent and proposed changes in land use. Specifically, 990-994 South Central Avenue, recently rezoned from I-1 to V, needs to be changed from an Industrial to Mixed-Use land use designation. Furthermore, properties acquired by the City on Orchard Street and Hamilton Avenue for public greenspace will be changed from Residential to Parks/Recreation land use. Finally, several properties within and adjacent to the Ford Redevelopment Area will be changed from Industrial to Mixed-Use land use designation. The amendment to the Future Land Use Map is a general housekeeping item that maintains and reinforces the legality of the City's zoning ordinance and Comprehensive Plan.

Chris Montesinos, Planning and Zoning Manager stated that this was a maintenance item to update the Comprehensive Plan in accordance with the 5 and 10 year DCA required updates.

D) Motion to Adopt, Ordinance No. 2008-22, Official Zoning Map, 1st Reading 12-02-08

Summary and Background Proposal to amend the Official Hapeville Zoning Map to incorporate the C-R to Village zoning changes on Dogwood Drive and to apply the new RMU zoning to specific parcels. An affirmative recommendation by the Planning Commission to amend the Zoning Map came on August 12, 2008.

Proposal to amend Article 22.1 – Chart of Dimensional Requirements to incorporate the lot area requirements for the RMU zoning district adopted by the Mayor and Council on November 4th, 2008. Article 22.1 is a table indicating setbacks, lot coverage, height, and parking spaces for each of the City's zoning districts.
