SUMMARY AND BACKGROUND

This Ordinance was formerly presented as two separate ordinances, 2013-04
Abandonment of Nonconforming Use and 2013-05 Exemption of Existing
Developments. Given the overlap between the two ordinances, they are now presented in a single ordinance format. This Ordinance proposes amending certain provisions of the nonconforming use section of the zoning ordinance to improve the monitoring, notification, and enforcement process associated with the loss of "legal nonconforming"

use" status by the owner. Also proposed is criteria for determining what constitutes abandonment as well as exempting certain developed properties from the strict enforcement of parking, floor area, and sidewalk width requirements upon their re-use following abandonment.
