House Bill 487, signed into law on April 10, 2013, authorizes the governing authority of municipal corporations to enact and enforce ordinances regulating Bona Fide Coin Operated Amusement Machines. This Ordinance establishes regulations for such machines in accordance with House Bill 487.

MOTION: Councilman Murray made a motion Councilman Lovern seconded a motion to adopt Ordinance 2013-07 Coin Operated Amusement Machines. Discussion: councilman Murray stated that the legislation allows the City to limit the number of coin operated devices at establishments. Motion carried 3-0.
