A. Consideration to approve the post-65 Retiree Health Reimbursement Account funding.

Summary and Background

Nicholson Transfer and Storage is a 200,000 sq. foot warehouse located on Milledge Street in East Point. They have a computer controlled inventory and rack availability. After inspection of the artifacts next week, Nicholson Transfer and Storage will give us an exact amount for the storage of these items.

Morsberger Revitalization has proposed the establishment of a Hapeville Airport Area Community Improvement District (CID) to be located on the northern side of the Hartsfield-Jackson Atlanta International Airport. The goals of this CID include upgrading the area's appearance; economic development; and traffic flow enhancement. This contribution would be for FY 2013-14 and come from the unappropriated balance of the general fund.
