A. Motion to Adopt Ordinance 2013-14 Alcohol Ordinance Amendment (On-Premises Arts License)

Summary and Background

This Ordinance amends the Hapeville Code of Ordinances to create and establish regulations for a new category of alcohol beverage license: an on-premises arts license. This Ordinance originally presented at first reading another new category of alcohol beverage license: an on-premises art gallery license. The on-premises arts gallery license component of this Ordinance has been removed and no substantive changes have been made from first reading in regard to the proposed on-premises arts license.

MOTION: Councilman Powell made a motion Councilman Dimmick seconded a motion to adopt Ordinance 2013-14. Motion carried 3-0. Alderman Ray abstained.

7. New Business

A. Motion to adopt Resolution 2014-03 South Fulton Comprehensive Transportation Plan

MOTION: Alderman Ray made a motion Councilman Randman seconded a motion to adopt Resolution 2014-03. Motion carried 4-0.

B. Consideration to enter into a Lease Agreement with Pitney Bowes for postage mailing system in the amount of \$17,280.00 for 60 months and to authorize the Mayor to sign all necessary documents pending legal review.

MOTION: Alderman Ray made a motion Councilman Dimmick seconded a motion to enter into a Lease Agreement with Pitney Bowes in the amount of \$17,280.00 for 60 months.

Discussion: Councilman Powell stated that this was a lot of money and inquired how many pieces of mail were going through the machine and if there had been consideration of other vendors.

C. 1st Reading Ordinance 2014-01 Art Gallery Alcohol Permit Summary and Background

This Ordinance amends the Hapeville Code of Ordinances to allow and establish regulations for a person or entity operating an art gallery to offer complimentary alcoholic beverages to patrons for consumption within the premises by obtaining an art gallery alcohol permit.

D. 1st Reading Ordinance 2014-02 Noise, Alcohol-Related Summary and Background

This Ordinance amends the Hapeville Code of Ordinances to provide a separate offense under the City's noise ordinance where the prohibited noise is accompanied by the use of alcohol. This Ordinance further clarifies that a violation of this new subsection may also provide a basis for revocation, refusal to renew, suspension, or probation of an alcohol beverage license under section 5-6-21(b) of the City's alcohol ordinance.

E. Discussion of summary action items from the Blueprint 2020 Plan.

It was a consensus of Council to hold a retreat on February 8th to discuss the plan and implementation thereof.

F. Discussion of Depot Plaza

City Manager, Bill Werner, presented the Council with roofing concepts for the depot plaza.

Mayor Hallman reminded the Council that the current concept had been approved previously by Council.

After much discussion it was the consensus of Council to this item to the February Agenda.
